December 3, 2021**

CALL TO ORDER: D. Lawrence, 1:00 PM

CORRECTION/APPROVAL OF MINUTES: The minutes of the Nov 5, 2021 faculty meeting were approved with a correction about the results of the Compiler motion which passed.

Dean of the Campus – Dr. Walter Collins, report submitted (updated report, [Appendix 1](#)).

- Covid19 numbers remain low – link in report.
- Thank you for all your work and a great Fall semester. Hope you enjoy the upcoming break.

Questions/comments from the floor: None

Penuel – last time we talked, you said you were going to have a talk with Brandon about the tenure bill. Is there anything you can add at this point?

Collins – I have talked to Brandon since that meeting on Tuesday about the bill to cut tenure out of SC public universities. Notes about the bill [please watch the recording for full details, about 6 minutes into video]. Bill Taylor originally submitted the bill – was chair of the higher education subcommittee for the house, until this year – Taylor will not be chair in January. In January, Tim McGinnis will be the new chair. From Brandon’s perspective this bill has little to no chance of going far. The person who submitted the bill is not there in January, so there is no one there to “push the bill”. Usually, the house member that submits the bill usually pushes the bill. [please see video] What Suzanne suggested [the statement form the faculty] is the right move and will not hurt. In January the house will reconvene, and we’ll know more about whether this bill will receive any traction.

Academic Success Center – Dr. Dana Lawrence - report submitted ([Appendix 3](#))

Admissions – Justin Pearson – shared a presentation – please see the video on Blackboard.

- Slogan “You’re way ahead when you start here”
- Number 1 in the state again.
- Revamped the admission packets this year with slogan, etc.
- Spring 2022 headcount 1335, DE 823, FTE 848; we are 22% ahead from last year for headcount and 16% for FTE.
- Fall 2021 headcount 1730 (-4% enrollment compared to 2020), DE 959 (-8%) and FTE 1144 (-1.5%). The differences are due to AP courses being offered the high schools.
- Freshmen enrollment is ~9% higher than Fall 2020. Differences appear to be DE and continuing student related.

Penuel – is the impression from this meeting that we should not reach out as a faculty about the Bill?

Burke – technical difficulties prevented a response from Burke.

In chat: I went back and listened again to the recording from the meeting. President Pastides believes there is strength in numbers and that going in as an united front would be the best approach. He is working with instate peer institutions and the CHE to oppose this bill. He stated there is a strong argument against passing this bill.

Penuel – the number of co-sponsors on the bill is creeping up, so this does look like this is going to be a serious thing in the future. Or maybe not.

Questions:

Cruise – Quick question and concern – is there any discussion on how much class athletes miss. From her own experience, she had a number of absences of the soccer players, more so than the other athletes. Can this be addressed and who needs to address this.

Easley –You are the second person to bring this up and she'll bring this up at the next meeting

Lekan – one thought connected to this – we might look into some standard form for athletes to bring to their faculty about dates that they may miss due to athletic events. Same format for athletes for all groups.

Easley – a checklist for the athlete to put a signature on this so that the student notifies the faculty. Something that the athlete has marked off about giving the schedule to the faculty members or missing class, etc.

N. Lawrence – like the others saying in the chat, he has also had this issue. The students that missed my classes, as Susan Cruise said, these students missed days or weeks. The students did notify him, so he did know they were going to miss. Maybe this is not on the students, but maybe this is more about the coaching staff and scheduling, more than on keeping faculty updated.

P. Lawrence – The bigger issue may not be that the faculty may not know that there is an absence, but that the student may not be keeping up with the work. He would worry that a form that the faculty member signs off on may give the student the idea that they are not responsible for the material they miss. Any form signed should not be a form that says the material is excused

Market – my situation is that I identified the athletes at the beginning of the semester. The baseball players have an excuse due to notification, but some of the athletes than show up in class. ... [please see video for more information] – there is no roster or game schedule up online or by the coaches, so there are discrepancies with some students claiming to have games that do not show up and others that do show up but are also athletes.

Taylor-Driggers – Would like to see advisors to these students know their practice schedule as well or be told about the schedule. The practices are interfering with class as well as the games.

Easley – as an advisor, she discusses this with her advisees that are athletes. This is a good reminder.

D. Lawrence – Liz you may have not seen all the comments in the chat.

Easley – comment on Moon-Kelley comment about reaching out to Nick Calhoon – any time there has been an athlete issue she has reached out to Nick and encourages faculty to reach out. Bettie’s comment about assessing participation and attendance grades – Question in chat: How should we assess participation / attendance grades for athletes missing class? Can we get some guidance to make this process smoother and more uniform?

1. Spring 2022 Advising and Registration Update

- a. As of November 29, **433 traditional degree-seeking** students have been registered compared to **375** this time last year. 267 were registered on November 1. Goal: 507.
 - b. As of November 29, **703 dual enrollment students** have been registered compared to **614** last year. Goal: 915.
 - c. New DE Students will register: December 7 and 9 (Bundy Auditorium) 5:30pm to 7:30pm (advising in Bradley 112 and 113).
2. **USCL Faculty Forums.** Forums run @noon on Zoom on FO Fridays. If you have some ideas for a presentation during Spring 2022, please let me know. Note that this does not have to be a formal talk. Roundtables and open-ended discussions are most welcome!
3. **Spring 2022 Calendar.** I have included a calendar for spring 2022 at the end of this report. The focus is on deadlines for faculty and student matters. Thanks to Pamela Ellis for her work on this.
4. **Faculty Information Forms for Annual Administrative Reviews.** These forms are due no later than *31 January 2022*. Supporting documentation is optional but may also be submitted electronically. Links by academic division are given below. The annual administrative review is completed by the Division Chairs and Associate Dean. Please note that these FIF forms will also be forwarded to the relevant peer review committee. That committee will perform its own separate evaluation. If you have any questions, please do not hesitate to reach out to my office, your Division Chair, or a Peer Review representative. At the end of this report, I have included USCL Peer Review guidelines for completing the FIF and the FIF form itself.

A redefined teaching or librarianship load is designed to allow tenured and tenure-track faculty members limited relief time from their normal duties in order to pursue significant scholarly projects designed to improve their capabilities and to increase their future contributions to the University. To be considered for a redefined teaching load, a faculty member must be on the tenure track or must have already been awarded tenure. If approved, faculty are not eligible for overload compensation during the term of course reduction. Please make these requests using the form included at the end of this report.
7. **New Staff Advisor.** Please join me in offering a warm welcome to **Zoe Byrd** who will be joining the Academic Affairs office on December 14 as a staff advisor. She is currently finishing her Bachelor of Arts in Liberal Studies and Graduation with Leadership Distinction in Diversity and Social Advocacy. During her time as a USCL student she has served as a PAL, volunteered with HOPE, participated in the Social Justice Program through Columbia, and worked as a DEIA summer intern with the Arras Foundation.
8. **Travel Study Requests.** The Student Affairs Committee monitors and reviews policies and practices in student development and extracurricular activities on the USCL campus, and it approves applications for travel study courses. The committee will have met the morning before this FO meeting to discuss the call for travel study requests. Look for that call in early January.

Annual Faculty Peer Review

UNIVERSITY OF SOUTH CAROLINA LANCASTER

PURPOSE

As stated in the *Palmetto College Campuses Faculty Manual*, the University of South Carolina is committed to annual review of all faculty. On the University of South Carolina Lancaster campus, each faculty member must undergo an annual peer review. The peer review process is designed to provide an opportunity to document the professional development of the faculty member, and to provide regular and constructive evaluations of the performance of the faculty member. Annual Peer Review also provides an opportunity to assess the contributions of the faculty member to the mission of USC Lancaster.

EXEMPTIONS FROM ANNUAL FACULTY PEER REVIEW

Each faculty member is required to undergo annual faculty peer review. Faculty members preparing files for first or third-year review, the tenure and promotion process, or post-tenure review may be exempted from the annual faculty peer review process. Those faculty members should refer to the *Manual* and to USC Lancaster's policies for the specific requirements of these reviews. Administrators subject to administrative review by faculty may elect not to undergo annual faculty peer review in addition to administrative review.

PREPARATION OF THE ANNUAL FACULTY PEER REVIEW FILE

Annually each faculty member shall complete a Faculty Information Form (FIF) detailing the faculty member's professional activities conducted during the previous calendar year. The FIF is arranged according to the criteria for tenure and promotion found in the *Palmetto College Campuses Faculty Manual*, and the faculty member is encouraged to consult the *Manual* closely in the preparation of the FIF. The criteria stated in the *Manual* recognize three broad areas: Effectiveness as a Teacher and/or Librarian, Scholarship, Service. In documenting effectiveness for these criteria, the faculty member should focus specifically on their contributions to the mission of USC Lancaster in the performance of each of these areas.

FACULTY EVALUATION

The Local Tenure and Promotion Committee evaluating the annual peer review files of tenured and tenure-track faculty will evaluate faculty on three categories, assigning a rating of Effective or Not Effective in each category, as well as an overall rating of Effective or Not Effective.

The Instructor Peer Review Committee will use the same method to evaluate full-time instructors, but because those instructors do not have a scholarship component to their job responsibilities, their evaluation will be based on Effectiveness as a Teacher and/or Librarian, omitting the Scholarship ranking. Full-time instructors who have scholarship accomplishments to report have the option of choosing to be evaluated by the Local Tenure and Promotion

Committee with the scholarship category included. A faculty member wishing to be evaluated in this way should indicate that preference by checking the appropriate box on the FIF. For a description of the current criteria for each of these areas, please refer to the most recent edition of the *Palmetto College Campuses Faculty Manual*. It is important that the faculty member include activities in each relevant section of the FIF, and the faculty member is encouraged to present limited narrative providing context and explaining the importance of the most significant activities included in the file. Faculty members should note that within the category of service, USC Lancaster sets a high priority on service to the community.

PROCEDURES AND DEADLINES

Annual peer review shall be conducted according to the following schedule:

- January 31** The faculty member shall have submitted a completed FIF to the office of the Associate Dean for Academic Affairs.
- February 15** The office of the Associate Dean for Academic Affairs shall have provided the appropriate review committees (hereafter referred to as “the committees”) access to the FIF for each faculty member undergoing annual faculty peer review.
- April 30** By this date, each member of the faculty will have received from the committees a written evaluation on the Peer Review Form (PRF). Each faculty member must sign his or her PRF acknowledging that the evaluation has been completed. This signature does not necessarily constitute agreement with the evaluation, and every faculty member has the right to respond to the annual peer evaluation in writing. The original of the signed PRF shall be given to the faculty member, and a copy shall be given to the Associate Dean for Academic Affairs, who will maintain the copy as a part of the faculty member’s personnel file.
- May 31** By this date, any faculty member who wishes to respond to the annual peer evaluation in writing must have submitted his or her response to the Associate Dean for Academic Affairs. Any written response from a faculty member to his or her PRF must be attached to the copy maintained in the office of the Associate Dean for Academic Affairs.

COMMITTEE PROCEDURES

Annual Faculty Peer Review will be conducted each year by the Tenure and Promotion Committee and the Instructor Peer Review Committee as detailed above. Evaluation of the faculty member will be based on the FIF submitted by that faculty member, and the evaluation will proceed in the following manner.

1. After review of the FIF, each member of the committees will evaluate the performance of each faculty member, producing brief comments for each of the areas of the criteria.
2. The appropriate review committee will meet and discuss each of the areas, determining an overall ranking for each candidate in each area as Effective or Not Effective, as well as an overall ranking for each candidate. If the committee cannot determine a ranking by consensus, the committee will conduct a vote with a tie resulting in a ranking of Effective. The committee should also at this time discuss and justify individual narrative comments and edit those comments for clarity as the committee deems necessary. It is desirable that the committee reach consensus in the preparation of the narrative comments, but when necessary, dissenting comments shall be included.
3. The Chair of each committee will collate the comments for each faculty member being evaluated and include these comments in the narrative section of the PRF.
4. Each member of the appropriate review committee must sign the PRF. These signatures do not necessarily indicate that all members of the committee agree with all comments on the form or the overall ratings, but rather indicate that the committee members have reviewed the PRF and that their comments and ratings have been included in the process.
5. Members of the committees may not participate in their own peer evaluations, and as such, members of the committees will not sign their own PRF's, except to acknowledge their receipt of the finished form at the completion of peer review.

Note: In the case of Faculty Librarians, the “teaching load” referred to herein will refer to the number of hours worked per week in librarianship duties. Also, where the Academic Division Chair is referred to herein, the Library Director will assume that same approval responsibility for faculty librarians.

A redefined teaching or librarianship load is designed to allow tenured and tenure-track faculty members limited relief time from their normal duties in order to pursue significant scholarly projects designed to improve their capabilities and to increase their future contributions to the University. It is designed to permit a faculty member to achieve educational goals which could not be reached if pursued under the demands of regular instructional duties. To be considered for a redefined teaching load, a faculty member must be on the tenure track or must have already been awarded tenure. **If approved, faculty are not eligible for overload compensation during the term of course reduction.**

Newly hired assistant professors will automatically be eligible for the redefined teaching load but will be expected to demonstrate progress in the area of productive scholarship in order to be considered for renewal. (This demonstration normally will occur during the annual evaluation process.)

The redefined teaching load normally will be defined in the following manner:

Distribution of the redefined load will be determined by the faculty member, subject to approval of the Academic Division Chair and the Associate Dean for Academic & Student Affairs, and will be based on the individual needs of the faculty member as well as the general needs of the campus.

APPLICATION PROCEDURES

1. A faculty member will submit a formal request for redefinition of teaching load to the appropriate Academic Division Chair. Requests are due by January 18.
2. In submitting a request, the faculty member will provide a **detailed** description of the proposed project, specifically addressing the following questions:
 - a) What are the educational goals that will be achieved in terms of teaching or scholarship?
 - b) How will this redefinition of load increase the faculty member's contributions to the mission of the University?
 - c) Will the project be complete at the end of the academic year for which a redefined teaching load is requested? If not, what is the anticipated timeline for completion?
 - d) How will the results of this project be demonstrated?
3. A request for redefined teaching load must be approved by the Academic Division Chair, Associate Dean for Academic and Student Affairs, and the Dean of the USCL campus.
4. Tenure-track assistant professors (i.e., untenured tenure-track faculty) are automatically eligible for the redefined teaching load but are still asked to submit a proposal.
5. Faculty members will include a detailed summary of all scholarly activity in their annual Faculty Information Forms. This summary will be used in determining any request for renewal and also may be used in determining approval of future requests for a redefined teaching load.

Campus Technology Update

December 3, 2021

Highlights

- **Recent Internet Outages:** I want to reiterate that these outages impacted multiple Palmetto College locations and are fully happening within the infrastructure of Segra, the network services provider for the University of South Carolina and multiple SC State Government entities. With this being the third outage inside of 20 days and second within 25 hours, this is being escalated with Segra. Both recent outages were fiber “cuts” and were caused by a third party. I also submitted a summary of these outage events for the last 2 years to the Division of IT Network Infrastructure group to be combined with data from other campuses and divisions within the University. I should have more information to share about this for my next report to the Faculty Organization. On the campus level, I have started a project to aggressively pursue activation of a secondary network path for the campus to provide Internet access if the primary network path fails.
- **Virus and Malware protection software:** The Division of IT is no longer licensing Symantec End Point protection nor Fireeye for computer virus and malware protection. Microsoft Defender is the product being adopted and deployed. This project is just over 80 percent complete. Most of the computers remaining are laptops. If you are using a University owned laptop, please expect to be contacted by a member of the IT Staff to coordinate this update.
- **Classroom Audio/Video upgrades:** A Purchase Order has been dispatched for the audiovisual upgrades in the Bradley Building. Installation dates for both active projects are still yet to be determined. Faculty will be notified as soon as the installation dates are schedules for both Founders Hall plus Bradley 120/121, NASC and the Bradley Building.
- **Other project updates:**
 - Bradley Classroom media computers: Should be received and installed by the start of Spring 2022.

- Our hybrid **Spring 2022 Internship Academy** will begin on Tuesday, January 18, 2022. We are once again very fortunate to have Bridgett Plexico serving as our coordinator for the academy. Participants will learn soft skills while exploring a range of career options through the online Microburst Learning EmployABILITY Soft Skills platform.

- Dr. Thad Westbrook (Invited Guest): gave update on the Presidential Search Committee (interviews have been conducted and there is a front runner that will be meeting with the Columbia Senate at the request of the Board of Trustees; date of this meeting has not been determined but should be scheduled shortly).
- Dr. Jason Stacy (Invited Guest): discussed the current positivity rates for the Columbia campus (1.4% average for fall semester, 0.3% currently) and the emergence of the Omicron variant (Covid protocols likely to remain in place for spring 2022 semester).
- Interim President Pastides: spoke about 1) tuition freeze for spring 2022; 2) the Covid protocols to continue in spring and the new variant; 3) Title IX training must be completed by December 17; 4) Provost and Vice President for Research searches are under way and will conclude in the spring semester; 5) effort to oppose the SC House Bill 4522 (Cancelling Professor Tenure Act) is underway with discussions among USC, peer state institutions, and CHE to make a good case against the bill; current tenure-track faculty and tenured faculty would be grandfathered in; new hires (after 12/31/2022) would be affected by this bill; 6) the SC House Bill 4605 (Freedom from Ideological Coercion and Indoctrination) seeks to ban Critical Race Theory (CRT) in SC schools.
